



ANTI-DUMPING NOTICE NO. 2014/121

Hot Rolled Structural Steel Sections

Exported from Japan, the Republic of Korea, Taiwan, and the Kingdom of Thailand

Termination of Part of a Dumping Investigation

Customs Act 1901 – Part XVB

On 24 October 2013, the Anti-Dumping Commission (the Commission) initiated an investigation into the alleged dumping of hot rolled structural steel sections (HRS) exported to Australia from Japan, the Republic of Korea (Korea), Taiwan and the Kingdom of Thailand (Thailand), following an application lodged by OneSteel Manufacturing Pty Ltd.

The Commission published a notice in *The Australian* on that date notifying of the initiation of the investigation, and issued Anti-Dumping Notice No. 2013/75, which contains further details on the investigation and is available at www.adcommission.gov.au.

As a result of the investigation, I, Dale Seymour, the Commissioner of the Anti-Dumping Commission (the Commissioner), am satisfied that, in relation to Feng Hsin Iron and Steel Co Ltd, an exporter of the goods from Taiwan, there has been no dumping by this exporter of any of those goods the subject of the application. I have therefore decided to terminate the investigation in accordance with subsection 269TDA(1) of the *Customs Act 1901* so far as it relates to Feng Hsin Iron and Steel Co Ltd.

In making the decision to terminate, I have had regard to the application for this investigation, data submitted by the exporter, Statement of Essential Facts No. 223, submissions from interested parties, and other relevant information received throughout the course of the investigation.

Termination Report No.223, which sets out reasons for the decision to terminate, including the material findings of fact or law upon which the decision is based, has been placed on the Commission's public record (accessible at www.adcommission.gov.au).

A notice of the decision to terminate was published in *The Australian* newspaper today.

The applicant may request a review of this decision to terminate part of the investigation by lodging an application with the Anti-Dumping Review Panel in the approved form and manner within 30 days of the publication of the public notice.

The investigation into the alleged dumping of the goods from Japan, Korea and Thailand, and all other Taiwanese exporters, will continue. The Commissioner's final recommendations and report in relation to the investigation was provided to the

Parliamentary Secretary to the Minister for Industry (Parliamentary Secretary) today. The Parliamentary Secretary's decision is due on 30 November 2014 unless otherwise extended.
